


## Q4 2022 Financial Results Conference Call Slides



#### **Net Sales**





#### Net Sales – TTM (1)





## Operating Income – TTM




## Net Income (Loss) (1)





## Net Income (Loss) – TTM $_{(1)}$





## Segment Results – North America





## Segment Results – International




TTM Net Sales \$118.0B; TTM Operating Loss \$7.7B



#### Long-Term Goal – Optimize Free Cash Flows


